- i. Managing Trustees after consultation with President and Board of trustees shall constitute a Governing Council for each of the college/School or institution run by the trust in accordance with the Rules for the time being in force. 11. POWER OF THE TREASURER:

12. POWER OF THE TRUSTEES:

- a. - b. The Trustees shall be entitled for reimbursement of all expenses incurred by them including traveling expenses for the purpose of the trust or attending the meeting of the trustees and are indemnified in respect of all acts done in the course of carrying the activity of the Trust.
- c. Trustees shall pass resolution by circulation in case of urgent issue. They may make rules for regulating their meetings and the trustees may repeal later any rules made pursuant to this clause.

22. GENERAL FUNCTION:

- This Trust is irrecoverable. If the Trust hereby constituted fail for any reason in the opinion of the Founder Trustees of the Trust the net assets of the Trust
